

# ROSEMOUNT AREA HOCKEY ASSOCIATION PARENT/GUARDIAN CODE OF CONDUCT

As a parent/guardian of a child involved in the Rosemount Area Hockey Association (RAHA), I/We agree to abide by and follow the rules and guidelines listed below:

1. I/We will respect the property and equipment used at any sports facility, both home and away.
2. I/We will encourage good sportsmanship through my/our actions, by demonstrating positive support for all players, coaches and officials, at every game or practice.
3. I/We will promote the emotional and physical well-being of the skaters, ahead of any personal desire to win.
4. I/We will provide support for coaches and officials, working with the skaters, to provide a positive experience for all.
5. I/We will demand a drug, alcohol, and tobacco free environment for my skater, and agree to assist by refraining from their use at all RAHA events, home or away.
6. I/We will remember the game is for the skaters and not for the parents.
7. I/We will demand my skater treat other players, coaches, officials and spectators, with respect, regardless of race, creed, color, sex or ability.
8. I/We will treat all players, coaches and officials with dignity and respect, in language, attitude, behavior and mannerisms.
9. I/We will inform the coach of any physical disability or ailment, that may affect the safety of my skater or the safety of others.
10. I/We will inform the coach, within a reasonable amount of time, of any absence from a game or practice, my skater might incur due to sickness, planned vacation or any other reason.

I/We also agree that if I/We fail to abide by the above rules and guidelines, I/We may be subject to disciplinary action. That this action could include, but is not limited to the following:

These actions may not be necessarily taken in an escalated manner, RAHA Board of Directors, reserves the right to select and apply any penalty dependent of the situation.

I/We agree to support the policies and procedures and promote the philosophy of RAHA: fair play, good sportsmanship and development of players of all ages.

For fair consideration, I, the undersigned parent/guardian of the above named player, hereby agree to fully and promptly pay any and all additional moneys required to be paid by traveling team members, in the event my son/daughter becomes a member of a RAHA traveling team. Also, I hereby give my approval to my child's participation to RAHA, I assume all risks and hazards incidental to such participation, including transportation to and from the activities: and do hereby waive, release, absolve, indemnify and agree to hold harmless RAHA, the organizers, sponsors, supervisors, participants and persons transporting my child to or from activities, for any claim arising out of an injury to my child, except to the limit or extent and in the amount covered by accident or liability insurance.

NO refunds except for medical reasons, by Doctor consent and Board approval.
